

RESOLUTION CANVASSING RETURNS AND
DECLARING RESULT OF BOND ELECTION
HELD NOVEMBER 3, 1979

WHEREAS, this Board of Trustees resolved and ordered that an election be held within this District on the 3rd day of November, 1979, for the purpose of submitting certain propositions to issue bonds under the provisions of Chapter 20 of the Texas Education Code to the resident qualified electors of the District; and

WHEREAS, it is hereby found and determined that said election was held in accordance with the authorizing proceedings, that notice of the election was duly given in the form, manner and time required by law, and that said election was in all respects legally held and conducted in accordance with the laws of the State of Texas applicable thereto; and

WHEREAS, the returns of said election have been made to this Board of Trustees and said returns, duly and legally made, show the following votes were cast on the propositions submitted at said election, to wit:

PROPOSITION NO. 1

"THE ISSUANCE OF BONDS IN THE AMOUNT OF \$8,750,000 AND THE LEVYING OF THE TAX IN PAYMENT THEREOF (NEW MIDDLE SCHOOL, BAND HALL, LIBRARY-MEDIA CENTERS AND OTHER RENOVATIONS AND IMPROVEMENTS)"

"FOR"	<u>1905</u> votes
"AGAINST"	<u>1118</u> votes
TOTAL VOTES CAST	<u>3023</u> votes

PROPOSITION NO. 2

"THE ISSUANCE OF BONDS IN THE AMOUNT OF \$195,000 AND THE LEVYING OF THE TAX IN PAYMENT THEREOF (CAMPUS STORAGE FACILITIES)"

"FOR"	<u>1548</u> votes
"AGAINST"	<u>1379</u> votes
TOTAL VOTES CAST	<u>2924</u> votes

PROPOSITION NO. 3

"THE ISSUANCE OF BONDS IN THE AMOUNT OF \$550,000 AND THE LEVYING OF THE TAX IN PAYMENT THEREOF (COVERED PLAY AREAS AND PAVING)"

"FOR"	<u>1315</u> votes
"AGAINST"	<u>1585</u> votes
TOTAL VOTES CAST	<u>2900</u> votes

PROPOSITION NO. 4

"THE ISSUANCE OF BONDS IN THE AMOUNT OF \$180,000 AND THE LEVYING OF THE TAX IN PAYMENT THEREOF (STADIUM IMPROVEMENTS)"

"FOR"	<u>1401</u> votes
"AGAINST"	<u>1519</u> votes
TOTAL VOTES CAST	<u>2920</u> votes

PROPOSITION NO. 5

"THE ISSUANCE OF BONDS IN THE AMOUNT OF \$515,000 AND THE LEVYING OF THE TAX IN PAYMENT THEREOF (MAINTENANCE SERVICE CENTER, BUS SHOP AND FOOD WAREHOUSE FACILITY)"

"FOR"	<u>1548</u> votes
"AGAINST"	<u>1404</u> votes
TOTAL VOTES CAST	<u>2952</u> votes


THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF KERRVILLE INDEPENDENT SCHOOL DISTRICT:

SECTION 1: That all of the recitals contained in the preamble of this resolution are found to be true and are adopted as findings of fact by this Board and as part of its judgment.

SECTION 2: That it is further found and determined that the results of the election as canvassed and tabulated in the preamble hereof properly represents the desires of those persons voting at said election.


