

RESOLUTION

WHEREAS, we, the members of the Kerrville Independent School District Board of Education, do acknowledge the great achievement accomplished by the 1982 Appraisal Review Board of Kerr County.

WHEREAS, it is also recognized that further actions to equalize values of properties so that each will bear the burden of taxation equally and uniformly, would delay certification of values and create hardships on many taxing units within the District.

WHEREAS, the hereinafter listed property is deemed to lack equality and uniformity in determining the appraised value, and that it is determined by the Appraisal Review Board of Kerr County that the properties will be reappraised for the year 1983.

NOW, THEREFORE, BE IT RESOLVED, that the above Board requests that records of the Kerr County Appraisal Review Board reflect that the Kerrville Independent School District did timely file a petition challenging the lack of uniformity and inequality of the appraisal of properties listed below, said properties being:
